Text of resolution:

This set of guidelines will establish how the JAG operates and functions, as directed by the Admiralty Board.

DUTIES FOR JAG OFFICER:

1. Must be very familiar with the STARFLEET Constitution, STARFLEET Membership Hand Book and able to learn any applicable Regional regulations.
2. Must be at least 23 years of age.
3. Immediate requests for assistance, whether via e-mail or phone call, must be followed up with a written request sent via snail mail which the JAG officer will keep in his/her records and must be received within two weeks of the initial contact with the JAG officer.
4. Upon request by the accused to the JAG for assistance, the JAG will inform all relevant parties of his involvement, including but not limited to the accused's Regional Coordinator, the CS, STARFLEET and the Inspector General.
5. Will act as an advisor (only) to the accused on their rights within STARFLEET, as well as where to get information and help.
6. Will assist any individual, Chapter, or Chapter in Training which is under investigation by the Inspector General's office.
7. Will not act as legal counsel to the accused.
8. Will not tell the accused not to cooperate with an investigation
9. Will not speak for the accused.
10. Will work to resolve disputes, not escalate them.
11. Will report to the Admiralty Board on a regular schedule setup by the AB, even when there is no activity to report.
